



Guidelines

- Adults 18 years and older are eligible.
- Entries must be original and created within the last 2 years. No kits or computer-generated art and no pieces previously entered in an Arts By The Shore show may be submitted.
- 2-Dimensional work must be no larger than 35" x 42", including frame and matting (securely framed and wired), ready to be hung—no exceptions. No saw tooth hangers.
- Constructive Design artwork must not be heavier than 50 pounds.
- No artwork may be removed before the show is over, and no artwork may be left in the building after the show ends.
- No artwork may be sold in the Recreation Center. Transactions are between the artist and the buyer after the artwork is removed from the show.
- An artist may enter 3 pieces in each of the 2 main divisions, 2 Dimensional and Constructive Design.


